**ANSWER:** Please see the answer for Question 15.

**Q30. I had the following questions regarding the ARPA-E RANGE project:**

**Q30.A. HOW IMPORTANT ARE THE TEAM PARTNERS INVOLVED IN THE PROJECT?**

**Q30.B. WHAT TRL NEEDS TO BE THE PROJECT?**

**Q30.C. CAN THE CONCEPT PAPER INCLUDE PERSONNEL AND FINANCIAL DATA?**

**Q30.D. IN WHAT FUNDING CATEGORIES CAN MY PROJECT \*\*\*\* BE AWARDED IN: PROOF-OF-CONCEPT SEEDLING PROJECT OR TECHNOLOGY DEVELOPMENT PROJECT?**

**ANSWER:** Q30.A. Please Section V.A.1 (Criteria for Concept Papers) of the FOA.  
Q30.B. ARPA-E does not specify a TRL-Level, as provided in Section I.A (Agency Overview), ARPA-E seeks transformational energy projects.  
Q30.C. Please Section IV.C (Content and Form of Concept Papers) of the FOA.  
Q30.D. Please see the answers for Questions 8 and 10.

**Q31. We are not sure what you are looking for relative to the funds and costs tab below. While we understand that a 20% cost share is required for the full application, our understanding was that a specific budget number was not needed for the concept paper submission. The ARPA-E exchange tool is not allowing us to submit our concept paper without populating the specific amount of our project contribution. Any guidance you can provide is appreciated.**

**ANSWER:** Applicants provide a “rough” cost estimate in ARPA-E eXCHANGE. Applicants may modify such cost estimates during the Full Application phase of the RANGE FOA.

**Q32. How may I request a reduced cost share in ARPA-E eXCHANGE?**

**ANSWER:** To request a reduced cost share pursuant to the terms of the FOA, Applicants must check the certification check box at the bottom of the “Funds and Cost” tab within ARPA-E Exchange (<http://ARPA-E-FOA.Energy.gov>).

**VI. Questions for week ending: APRIL 26, 2013**

**Q33. I am wondering if you can provide us with comments from individual reviewers on our Concept Paper?**

**ANSWER:** ARPA-E provides Applicants with summary feedback on Concept Papers, based in part on reviewer comments, in order to guide the further development of their proposed technology.

**Q34. On page 20 of the FOA (Mod. 1) it states “Proof-of-Concept seedlings are projects which both range between \$250,000 and \$1,000,000 and have a period of performance of no more than a year.” Are these dollar numbers meant to refer to the ARPA-E award amount or the total project cost (i.e. Award + Cost Share)?**

**ANSWER:** The dollar thresholds established in Section II.A (Award Overview) of the FOA refers to the total amount of Federal funding that ARPA-E may issue to an Awardee. This threshold does not include an Awardee’s required cost share amount, as explained in Section III.B (Cost Sharing) of the FOA.

**Q35. We missed the concept paper submission deadline. Can we still submit a concept paper for consideration?**

**ANSWER:** No. Once the Concept Paper Submission deadline has passed the ARPA-E Exchange system will not allow the creation of, or submission of any new Concept Papers. In addition, an Applicant must successfully submit a Concept Paper in the ARPA-E Exchange system to be eligible to create and submit a Full Application for this funding opportunity. Please see Full Application compliant criteria detailed in Section III.C.1 (Compliant Criteria) of the FOA.

**VII. Questions for week ending: MAY 3, 2013**

**Q36.A. There is a 20 page limit on R&D strategy. Does this limit include text, figures and references? Can I list references in appendices to the R&D strategy section or to the complete proposal instead?**

**Q36.B. The required documents checklist on P.1 states “Statement of Project Objectives (5 pages max.)” Whereas on P.38 is says “1 page max”. So, is it a 5 or a 1 page limit?**

**ANSWER:** Q 36.A: Yes. The 20 page limit includes text, figures, and references. Applicants should present supporting references, data, calculations, estimates, and/or projections in the R&D Strategy section, and not include appendices. Please see Section IV.D.1 (Content and Form of Full Applications – First Component: Technical Volume) of the FOA.

Q 36.B: On May 3, 2013, ARPA-E posted a modification to the RANGE FOA which clarified that the page limit for the Statement of Project Objectives is 1 page. Please visit ARPA-E eXCHANGE (<https://arpa-e-foa.energy.gov>) to access the modified FOA.

**Q37. We would like to change our prime recipient from one team member to another. Please advise if there is any issue with this as we proceed with our full application submission.**

**ANSWER:** Yes. Applicants may expand or otherwise modify the proposed Project Team for their Full Applications.

**Q38. On page 38 of the FOA a maximum of 2 pages is listed to discuss technology to market strategy in the technical volume, while the required technical volume says 5 pages are allocated for this section. Can you please confirm which page limit should be followed?**

**ANSWER:** Please see Section IV.D.1 (Content and Form of Full Applications – First Component: Technical Volume) of the FOA. Applicants must limit the Technology-to-Market Strategy to two pages.

**Q39.A In a project team if a domestic educational institution is not performing at least 80% of the work can our cost share portion be at least 5% and our subrecipients who are large business must provide 20% of the total project cost? This would then make the total cost share 25% of the total project cost.**

**Q39.B If there are 3 subrecipients are they all required to provide 20% or can the total cost share amount of their contribution equal 20% of the total budget?**

**ANSWER:** Q 39.A: As stated in Section III.B.5 (Cost Share Allocation) of the FOA, each Project Team is free to determine how much each Project Team member will contribute towards the cost share requirement. The amount contributed by individual Project Team members may vary, as long as the cost share requirement for the project as a whole is met. Although the cost share requirement applies to the Project Team as a whole, the funding agreement makes the Prime Recipient

legally responsible for paying the entire cost share. The Prime Recipient is solely responsible for managing cost share contributions by the Project Team and enforcing cost share obligations assumed by Project Team members in sub-awards or related agreements.

Q39.B: Please see III.B.5 (Cost Share Allocation) of the FOA. The cost share requirement applies to the Project Team as a whole, not individual team members. Therefore, each Project Team is free to determine how much each Project Team member will contribute towards the total cost share requirement. The amount contributed by individual Project Team members may vary, as long as the cost share requirement for the project as a whole is met.

**Q40. Can you please define “substantially” in terms of the U.S. Manufacturing Requirement?**

**ANSWER:** The term “substantially” in terms of the U.S. Manufacturing Requirement is not defined in law or regulation. Thus, this is a policy determination, dependent on the circumstances of each award.

**Q41. The FOA requests references to be identified in the proposal but doesn't state exactly how ARPA-E wishes to have references included in the applications. Can applicants submit an appendix document with the application that includes all the references?**

**ANSWER:** Please see the answer for Question 36.A.

**Q42. The required documents checklist immediately following the table of contents in the FOA states that the maximum page count for technology-to-market strategy is 2 pages. The technical volume template states that the maximum page count for technology-to-market strategy is 5 pages. What is the correct maximum page count for the technology-to-market section?**

**ANSWER:** The correct maximum page count for the technology-to-market section of the technical volume is 2 pages. The technical volume template available on ARPA-E eXCHANGE has been updated to reflect this correction. Please visit <https://arpa-e-foa.energy.gov> to access the updated technical volume.

**VIII. Questions for week ending: MAY 10, 2013**

**Q43. Has a date been established for 2nd round of questions?**

**ANSWER:** For a complete listing of deadlines, please see the cover page of the RANGE FOA. The deadline to submit questions for the Full Application phase is 5PM ET, May 30, 2013.

**Q44.A On page 44, the FOA states that if an applicant is a DOE/NNSA FFRDC, a field work proposal is required. Is this in addition to the business assurances, or will the field work proposal serve in lieu of the business assurances form if the applicant is a DOE/NNSA FFRDC?**

**Q44.B The FOA states the applicant may request a waiver of the foreign work requirement using the business assurances form. I do not see any specific language on the Business Assurances Form requesting a waiver for work by foreign entities that must be performed by subsidiaries or affiliates incorporated in the U.S. (including U.S. territories). Does the Business Assurances Form have a specific section to make this request or is there any specific language to be included on the Business Assurances Form for this requirement?**

**ANSWER:** Q 44.A: The field work proposal is submitted as a part of the Business Assurances Form. The field work proposal should not be submitted in replacement of the Business Assurances Form.

Q 44.B: A waiver of the foreign work requirement is necessary if an Applicant wants to perform work outside of the United States. To request a waiver, Applicants must make the request in Section 4 of the Business Assurances Form.

**Q45.A. If the project lead is a domestic educational institution and is planning on forming a project team does the lead team (educational institution) have to perform 80% of the work?**

**Q45.B. If the project lead is a domestic educational institution and they are not providing 80% of the work, is the required cost share portion then reduced to 5%?**

**Q45.C. If the project lead is a domestic educational institution, and they are not performing 80% of the work, is the required cost share portion then reduced to 5% even though their subs are not non-profits?**

**Q45.D. If there are 3 subrecipients are they all required to provide 20% of the total budget or is it 20% of their portion of the budget?**

**ANSWER:** Q45.A: No.

Q45.B: No. Project Teams where domestic educational institutions, domestic nonprofits, and/or FFRDCs perform greater than or equal to 80%, but less than 100% of the total work under the funding agreement (as measured by the Total Project Cost) are required to provide at least 10% of the Total Project Cost as cost share. Please see Section III.B.3 of the FOA (Reduced Cost Share Requirement).

Q45.C: No. Please see Section III.B.3 of the FOA (Reduced Cost Share Requirement) and the answer for Question 45.B, above.

Q45.D: Please see the answers for Question 39.A and 39.B.

**Q46. Since Proof-of-Concept seeding projects focus on early stage, Proof-of-Concept level R&D effort, TT&O activities are mostly likely not involved. Does the mandate 5% TT&O costs still apply to the seeding projects?**

**ANSWER:** Yes. Every Project Team must spend at least 5% of the Federal funding (i.e., the portion of the award that does not include the recipient's cost share) provided by ARPA-E on TT&O activities. Please see Section IV.G.8 of the FOA (Technology Transfer and Outreach).

**IX. Questions for week ending: MAY 17, 2013**

**Q47. Are we allowed to include letters of support (i.e. from unfunded collaborators) and if so, where does it go and does it count towards the page limit?**

**ANSWER:** Letters of support may be included in the Technical Volume of the Full Application. Such letters will count towards the page limit applicable for each section of the Technical Volume. For information on page limits, please see Section IV.D.1 (First Component: Technical Volume) of the FOA. Please be advised that ARPA-E will not consider letters of support during the Full Application selection and review process.

**Q48. In the solicitation it states the following: “project teams where domestic educational institutions, domestic nonprofits, and/or FFRDCs perform greater than or equal to 80%, but less than 100%, of the total work under the funding agreement (as measured by the total project cost) are required to provide at least 10% of the total project cost as cost share. However, any entity (such as a large business) receiving patent rights under a class waiver, or other patent waiver, that is part of a project team receiving this reduction must continue to meet the statutory minimum cost share requirement ( 20%) for its portion of the total project cost. Is the educational institution required to provide 10% of the total project cost or is it 10% of their portion of the total budget?**

**ANSWER:** In a situation where a Project Team includes a domestic educational institution that will perform greater than or equal to 80%, but less than 100%, of the total work (as measured by total project cost); the Project Team must provide at least 10% of the total project cost as cost share. (The Project Team’s cost share is not based on the educational institution’s portion of the total budget). However, a large business receiving a patent class waiver (part of the Project Team) that performs 20% or less of the work, must provide at least 20% cost share for its portion of the total project cost. Please see Section III.B.3 (Reduced Cost Share Requirement) of the FOA.

**Q49. We have recently come across your funding opportunity: DE-FOA-0000869: Robust Affordable Next Generation Ev-storage (range). I am aware that the “Concept Paper submission” deadline has passed but if ARPA-E has interest in our idea, we were wondering whether the deadline could be extended?**

**ANSWER:** ARPA-E cannot extend the DE-FOA-0000869 Concept Paper submission deadline or accept any new Concept Papers after the submission deadline. Applicants must have submitted a Concept Paper in ARPA-E Exchange to be eligible to submit a Full Application. Please see Section III.C.1 (Compliant Criteria for Full Applications) of the FOA.

**Q50. Will ARPA-E provide the complete review comments on our concept paper?**

**ANSWER:** ARPA-E provides Applicants with summary feedback on Concept Papers, based in part on reviewer comments.

**X. Questions for week ending: MAY 24, 2013**

**Q51. If we do not plan to request a waiver regarding the US manufacturing requirement should we still respond to questions 7a through 7f?**

**ANSWER:** No.

**Q52. Are the subrecipients required to submit a business assurance form and other sources of funding disclosure?**

**ANSWER:** Only the proposed Prime Recipient is required to submit a Business Assurances Form and Other Sources of Funding Form.

**Q53. After submitting the concept paper, for the full proposal: are we allowed to change from technology development project to proof-of-concept seedling project?**

**ANSWER:** Yes.

**Q54. Are licensing costs between team members considered part of project cost and therefore can be considered TT&O cost. Or are those cost not considered associated with project cost?**

**ANSWER:** Since ARPA-E awards are for research, “licensing costs” between team members are not considered part of project cost.

**Q55. Does ARPA-e allow fee as part of the project cost? Our industrial partner has worked with DOD in the past and DOD allowed up to 5% fee.**

**ANSWER:** No, fee is not allowed as part of the project cost.

**Q56. Our proposal will be one year start date 11/1/2013 end date 10/31/14. Does year 1 on budget justification represent fiscal year? If so then our budget would be 11 months in year 1 and (1) month in year 2. Do you agree?**

**ANSWER:** In this context, the year refers to calendar year, not a fiscal year.

**XI. Questions for week ending: MAY 30, 2013**

**Q57. Regarding the referenced FOA, should the following forms be actually signed and then those signed pages be scanned to a PDF file, which is inserted into the referenced form file.**

**This question is being asked for the following forms**

- **Application for Federal Assistance SF-424**
- **Business Assurances Form**
- **Other sources of Funding Disclosure Form**

**ANSWER:** Yes.

**Q58. I have a question regarding the total amount of a project budget for a range proof-of-concept seedling project: Does the \$1 million maximum budget refer to the entire project cost, including cost share, or does it refer to the amount we may request from the DOE?**

**ANSWER:** The \$1 million maximum budget refers to the funding amount that may be requested from ARPA-E.

**Q59. For completing the budget of our ARPA-e proposal (range) and submitted via a University, we were wondering whether it is possible to have the funding of one of our partners on the proposal to go via a different institution. The idea is similar to a joint-proposal setup as done in NSF so that our partner's share of the award is funded via a 501(c)(3) nonprofit research organization, having less overhead then when funded via a sub contract and subjected to a University's overhead.**

**ANSWER:** Total federal funds are provided under the award document only to the prime recipient. Reimbursement to its project team members is solely at the prime recipient's discretion.
