Proposed Action Title: (0472-1526) Ames Laboratory - Development of Ce-Based Permanent Magnets

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Ames, IA; Warren, MI

Proposed Action Description:

Funding will support development of a Ce-Transition Metal magnet for use in electric drive motors that has a Curie temperature in excess of 300, a remnant magnetization in excess of 1 T, and coercivity in excess of 10KOe. Ames' application was selected for an initial 18-month period (Phase 1) of funding. The ARPA-E Program Director may decide to negotiate and fund project activities for an additional 18-month period (Phase II) after evaluating the work performed in Phase I. ARPA-E has not obligated funds or negotiated a scope of work for Phase II at this time. Accordingly, this categorical exclusion determination form addresses only the activities that will occur in Phase I of this project.

Proposed work will consist of an indoor, dual-track experimental and theoretical series of activities, including, on the experimental side, (1) creation and examination of interstitially modified Ce-TM magnet materials; (2) creation and examination of substitutionally-modified Ce-TM materials; and (3) preparing aligned, exchange-coupled nanostructure between Ce-TM compounds and those containing critical rare earths. Theoretical project activities will include: (1) ascertaining the undefected structure, its relative stability, and determining the necessary intrinsic properties; (2) calculating the stability and favorability of structural defects; and (3) assessing the extrinsic properties based on the results of the first two activities.

Ames will undertake design, analysis, and testing activities at its laboratory facilities in Ames, IA; General Motors will carry out design, analysis, and testing activities at its R&D facilities in Warren, MI.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
