Proposed Action Title: Advanced Magnet Lab, Inc. -- Homopolar Machines Enabled With Electron Current Transfer Technology

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Melbourne, FL; Mebane, NC; Raleigh, NC

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop electrodes for contact-free current transport with sufficient size and performance for motor/generator applications. Specifically, the project team will (1) define electrode performance metrics; (2) determine most appropriate substrate for motor/generator applications; and (3) optimize the down-selected process to demonstrate electrode performance (current density, voltage, durability, thermal management, etc.). If successful, the project team will demonstrate contact-free current transfer capable of replacing mechanical brushes as well as liquid contacts in traditional homopolar machines, offering increased reliability and efficiency, and enabling superconducting homopolar electrical machines with improved power and torque density.

Project activities will be conducted at existing facilities at Advanced Magnet Lab, Inc. (Melbourne, FL), Eagle Power Technologies (Mebane, NC), and North Carolina State University (Raleigh, NC) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further MEPA review.
