Proposed Action Description:

Funding will support the design and development of a production-ready, electrochemical-based, handheld aluminum identification system. If successful, the cost-effective automated sorting of aluminum alloys will directly contribute to U.S. vehicle light-weighting, improved fuel efficiency, and reductions in vehicle embodied energy. Project tasks involve small-scale research and development activities in Palo Alto, CA, and will comply with applicable federal, state, and local requirements.

Proposed Action Description:

The Palo Alto Research Center proposes to conduct small-scale, laboratory based, research, development, and testing of key enabling technologies for a disrupting electrochemical contact probe that is capable of identifying a range of metals and alloys. The proposed activities aim to scan and sort light metal scrap materials with high accuracy and speed to improve industrial performance and reduce recycling costs.
