Proposed Action Title: Michigan State University - Diamond Diode and Transistor Devices

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): East Lansing, MI

Proposed Action Description:

Funding will support small-scale, research and development activities for building high voltage diamond diodes and transistors. Specifically, the project team proposes to: (1) measure electrical properties of the various doped diamond materials needed to build the diode structures, conduct 2D diode simulations in order to determine required geometry and doping profiles that achieve electrical performance targets; (2) fabricate test diodes of different designs and demonstrate test diodes to target specifications; (3) evaluate fabrication costs using information on the diamond diode fabrication. If successful, the proposed activities aim to produce diamond diodes and transistors capable of operating at higher temperatures and voltages, and higher power switching capabilities.

Project tasks will be conducted at existing facilities, and will be conducted in accordance with applicable Federal, State, and local safety and environmental requirements.
