Proposed Action Title: (0208-1610) GE Global Research - CO2 Capture Process Using Phase-Changing Absorbents

Program or Field Office: Advanced Research Projects Agency - Energy (ARPA-E)

Location(s) (City/County/State): GE Global Research Center (Niskayuna, NY)

Proposed Action Description:

Funding will support continued research under ARPA-E Award DE-AR0000084 to construct, operate, and evaluate an integrated, continuous bench-scale carbon dioxide (CO₂) capture system that uses phase-changing absorbents. Specific tasks include (1) redesigning the system spray chamber to enable continuous flow-through of carbonamate particles, (2) integrating all unit operations into a continuous bench-scale system, and (3) performing various analytical tests to evaluate system performance.

Project tasks will be conducted on a small-scale, pilot basis in industrial laboratory, testing, and office facilities at the GE Global Research Center (Niskayuna, NY). Project tasks will be performed for a period of up to 12 months.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.


