**Proposed Action or Project Description:**

American Recovery and Reinvestment Act:

Funding will support laboratory and bench scale research and development on flow-assisted rechargeable zinc manganese dioxide batteries toward the development of low cost grid-scale energy storage. The proposed work is consistent with the goal of GRIDS: development of new technologies to enable the widespread deployment of cost-effective, grid-scale energy storage.

Work consists entirely of RD&D to be completed at the CUNY Energy Institute laboratory in New York, NY, and the Rechargeable Battery Corporation laboratory in College Station, TX. The work performed will be limited to research, development, testing, and evaluation.


