Proposed Action Title: (0675-1578) Robert Bosch LLC - Advanced Battery Management System

Proposed Action Description:

Funding will support efforts to develop an adaptive battery management system that controls battery charging and discharging so as to enable fuller, more efficient battery utilization. Proposed work will consist of: (1) development of real-time estimation and control strategies for estimating battery performance; (2) design, development, and fabrication of small-scale Lithium-ion battery cells with an electrochemical-based battery management system; and (3) conducting analytical modeling and testing to characterize and validate system performance.

Project tasks will be conducted at Bosch Research and Technology Center North America (Palo Alto, CA), Cobasys, LLC (Orion, MI), and the University of California - San Diego (San Diego, CA). All experimental project tasks will be performed on a small-scale, pilot basis in dedicated industrial laboratory and office facilities at Bosch Research and Technology Center North America and Cobasys, LLC. University of California - San Diego will perform exclusively analytical work and will not conduct laboratory-based experimental tasks. Project tasks will be performed for a period of up to 36 months.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
