Proposed Action Title: (0473-1611) General Atomics - Magnetically Pulsed Hybrid Breaker for HVDC Power Distribution Protection

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): San Diego, CA; Mississippi State, MS

Proposed Action Description:

Funding will support development of a magnetically pulsed hybrid circuit breaker for use on high voltage direct current (HVDC) transmission lines, which are needed to transport electricity generated by renewable sources over long distances through multi-terminal mesh and branch networks.

Proposed work will consist of (1) computer-based design of the interrupter and commutation circuit; (2) indoor fabrication and low-voltage, low-energy testing of the interrupter, commutation circuit, and a prototype HVDC circuit breaker incorporating both components; and (3) indoor high-voltage testing of the prototype HVDC circuit breaker to verify the feasibility of the HVDC circuit breaker concept.

Proposed high-voltage testing of the prototype HVDC circuit breaker will take place at Mississippi State University's High Voltage Laboratory in Mississippi State, MS. All other proposed work will take place at General Atomics' facilities in San Diego, CA.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
