Proposed Action Title: Lawrence Berkeley National Laboratory - MEMS RF accelerators for materials and energy applications

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Berkeley, CA; Ithaca, NY

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a novel class of ion accelerators that can be scaled to high beam current and beam energy using a modular approach. Specifically, the project team will 1) develop a basic proof-of-concept multi-beam design and fabricate it using low cost materials and fabrication techniques and 2) perform additional testing and validation experiments. If successful, this competitively-priced, multi-beam linear accelerator would create a class of low cost, flexible, and scalable ion accelerators that could enable the rapid development of nuclear materials for the advanced nuclear energy field and new applications in manufacturing.

Project activities will be conducted at existing facilities at Lawrence Berkeley National Laboratory (Berkeley, CA) and Cornell University (Ithaca, NY) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
