Proposed Action Title: Massachusetts Institute of Technology - Multimetallic Layered Composites (MMLCs) for Rapid, Economical Advanced Reactor Deployment

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop multi-metallic layered composites (MMLCs) for use in structural and fuel cladding materials in Generation IV fission reactors. Specifically, the project team will (1) develop MMLCs design principles and best practices, (2) develop commercial alloys and test performance, and (3) fabricate MMLCs at a larger scale. If successful, this project could lead to commercially-ready MMLCs that will outperform current materials at lower cost, disrupting the current methods in materials manufacturing and testing for advanced nuclear reactors.

Project activities will be conducted at existing facilities at Massachusetts Institute of Technology (Cambridge, MA), Idaho National Laboratory (Idaho Falls, ID), Louisiana Tech University (Ruston, LA), and Georgia Institute of Technology (Atlanta, GA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work. Massachusetts Institute of Technology, under the terms of its ARPA-E Cooperative Agreement, is prohibited from commencing project work involving radiological materials before (1) obtaining the necessary permits and approvals and (2) providing written assurances to ARPA-E of the same.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
