Proposed Action Title: Nanocomp - High Value Energy Saving Carbon Products and Clean Hydrogen Gas from Methane

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Merrimack, NH; Wilmington, DE; Lincoln, MA; Cambridge, MA; Richmond, VA

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to build the technical and commercial foundation for converting natural gas into clean hydrogen and a unique structural carbon material, at an industrial scale. Specifically, the project team will (1) design a reactor that is technically and economically relevant to the industry, (2) demonstrate high levels of hydrogen purification and carbon capture efficiency, and (3) develop scaling models and economic analyses to support industrial-scale deployment. If successful, this project would lead to enabling technologies and perform the preliminary design of a system to convert 1 quad of methane into 14 million metric tons of structural carbon and 0.63 quads of hydrogen per year.

Project activities will be conducted at existing facilities at Nanocomp (Merrimack, NH), Massachusetts Institute of Technology (Cambridge, MA), DowDupont (Wilmington, DE), Pi Orbital (Richmond, VA), and the Boston Consulting Group (Lincoln, MA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.


To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
