Proposed Action Title: AltaRock Energy, Inc. -- RePED 250: A Revolutionary, High-Drilling Rate, High-T Geothermal Drilling System and Companion (250 - 350°C) Power Electronics

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a front-end waveguide system to deliver a millimeter wave (MMW) beam to the rock surface, with collinear diagnostics for remote monitoring and collinear purge gas injection for material removal. Specifically, the project team will (1) conduct higher pressure experiments in a rock test chamber; (2) perform multiphysics modeling of MMW boring system; (3) cold test the new waveguide front-end system on lab bench; (4) demonstrate rock removal at target aspect ratios and utilize data to determine rock removal rates and efficiencies; and (5) develop system analysis report and conduct a systems study to determine requirements for a commercial deep drilling system, along with power and pressure limits for the components. If successful, the project team will demonstrate the use of MMW directed energy technology for rock destruction, borehole stabilization, and material removal at increasingly larger aspect ratios.

Project activities will be conducted at existing facilities at MIT & Quaise, Inc. (Cambridge, MA); Air Force Research Laboratory (Albuquerque, NM); Impact Technologies (Tulsa, OK); and AltaRock Energy (Seattle, WA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.


