Proposed Action Title: Virginia Polytechnic Institute and State University -- 20-kV GaN Switch Technology Demonstrated in High-Efficiency Medium-Voltage Building Block

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop Gallium Nitride (GaN) devices that reduce loss several times below and increase the voltage-speed envelope several times above state-of-the-art silicon carbide devices. Specifically, the project team will (1) develop and refine metal-organic chemical vapor deposition (MOCVD) processes enabling improved epitaxial growth and materials characterization, (2) design and fabricate batches of GaN modules for testing; and (3) conduct reliability modeling to quantify thermal performance. If successful, the GaN devices would enable solid-state transformers and circuit breakers, which favor wide-bandgap devices with loss below 0.5% of output power. Additionally, the packaging innovations would enable the team to show the full potential of high-voltage, high temperature, and fast-switching GaN devices in a medium-voltage power converter.

Project activities will be conducted at existing facilities at Virginia Tech (Blacksburg, VA), University of Notre Dame (Notre Dame, IN), SixPoint Materials (Buellton, CA), United Technologies Corporation (East Hartford, CT); and NREL (Golden, CO) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.
