Proposed Action Title: ABB, Inc. - Economical Data-fused Grid Edge Processor (EDGEPRO) for Future Distribution Grid Control Applications

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to merge advanced computing technologies, machine learning methods, and grid applications into a comprehensive, next-generation grid control and monitoring device. Specifically, the project team will (1) design and build the EDGEPRO hardware device, (2) develop data fusion/machine learning techniques for virtual metering, and (3) demonstrate the EDGEPRO-based distributed grid applications in laboratory and real-world environments. If successful, the EDGEPRO technology would provide a low-cost (\$300 per unit), secure, and flexible grid-edge service platform to enable large scale deployment of distributed energy resources, service-oriented asset management, and flexible customer-oriented control.

Project activities will be conducted at existing facilities at ABB, Inc. and North Carolina State University (Raleigh, NC) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work. Additional field testing will take place at a yet to be determined utility location. Prime Recipient ABB, Inc., under the terms of its ARPA-E Cooperative Agreement, is prohibited from commencing applicable project work involving field testing of the EDGEPRO device at a to-be-determined utility partner before (1) obtaining the necessary permits and approvals and (2) providing written assurances to ARPA-E of the same.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
