Proposed Action Title: Ohio State University - GaN MOCVD growth on native substrates for high voltage (15-20 kV) vertical power devices

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Columbus, OH; Buellton, CA

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop Gallium Nitride (GaN) semiconductor materials suitable for high voltage vertical power devices for efficient control and conversion of electric power. Specifically, the project team will (1) develop high quality GaN substrates with reduced defect densities, (2) employ a unique photon-assisted metalorganic chemical vapor depositions (MOCVD) method to grow GaN films, and (3) conduct high voltage device design, fabrication, and testing. If successful, the project will enable GaN based wide bandgap semiconductor power devices well-suited for high current and high voltage applications, promising significant energy efficiency gains in power electronics.

Project activities will be conducted at existing facilities at Ohio State University (Columbus, OH) and SixPoint Materials, Inc. (Buellton, CA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. Modifications will be made to the existing facilities at Ohio State to accommodate the proposed work, including the installation of a high power laser. Ohio State University, under the terms of its ARPA-E Cooperative Agreement, is prohibited from commencing applicable project work involving facility modifications before (1) obtaining the necessary permits and approvals and (2) providing written assurances to ARPA-E of the same.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
