Proposed Action Title: Palo Alto Research Center, Inc. (PARC) - High-throughput methane pyrolysis for low-cost, emissions-free hydrogen

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to demonstrate a high throughput molten-metal methane pyrolysis reactor. Specifically, the project team will (1) develop a techno-economic model that demonstrates the economic feasibility of this concept, (2) perform bench-scale validation of the proposed pyrolysis reactor, and (3) demonstrate a commercially-viable methane pyrolysis method. If successful, this project will develop a natural gas pyrolysis process that would enable emissions-free hydrogen production at cost-parity with steam methane reforming.

Project activities will be conducted at existing facilities at Palo Alto Research Center (Palo Alto, CA), Creative Engineers, Inc. (New Freedom, PA), Gas Technology Institute (Des Plaines, IL), Stony Brook University (Stony Brook, NY), and Cabot Corporation (Boston, MA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. Modifications will be made to the existing facility at PARC to accommodate the proposed work, including upgrading the ventilation system and installing gas and temperature sensors. PARC, under the terms of its ARPA-E Cooperative Agreement, is prohibited from commencing applicable project work involving facility modifications before (1) obtaining the necessary permits and approvals and (2) providing written assurances to ARPA-E of the same.


The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
