Proposed Action Title: Pennsylvania State University -- Direct Write Wireless Sensing for Increasing Energy Efficiency

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop and demonstrate a method for the integration of additively manufactured sensors into additively manufactured gas turbine components. Specifically, the project team will (1) complete conceptual designs of integrated sensor system and define performance metrics; (2) fabricate, test, and evaluate sensors; (3) design thermal management system and packaging for wireless signal and power system; and (4) validate complete measurement system. If successful, the project team will demonstrate a new measurement system exceeding the state of the art measurement capabilities for test-engine and condition-based maintenance applications for stationary and aircraft engines

Project activities will be conducted at existing facilities at Pennsylvania State University (College, PA), Georgia Institute of Technology (Atlanta, GA), Siemens Corporation, Corporate Technology (Princeton, NJ; Charlotte, NC; Casselberry, FL; Orlando, FL), United Technologies Research Center (East Hartford, CT), and CVD MesoScribe Technologies Corporation (Central Islip, NY) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.


The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
