Proposed Action Title: Hewlett Packard Enterprise -- Ultra-Energy-Efficient Integrated DWDM Optical Interconnect

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to design and fabricate an innovative, energy-efficient, dense wavelength division multiplexing (DWDM)-based integrated photonic interconnect solution for high-performance computing. Specifically, the project team will (1) create novel designs in architecture, new types of microring modulators, a further improved sensitive receiver, and replace power-hungry thermo-optic tuning with its "zero-power" tuning technique; (2) develop heterogeneous system components and an advanced bonding and epitaxy integration platform; and (3) conduct full device runs and transceiver chip fabrication and testing. If successful, the project team will demonstrate a "bandwidth scale-up, energy scale-down, volume manufacturable" silicon photonic package solution, and enable a horizontally integrated and open photonic ecosystem for more silicon photonics users and beneficiaries.

Project activities will be conducted at existing facilities at Hewlett Packard Enterprise (Palo Alto, CA) and University of California, Santa Barbara (Santa Barbara, CA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
