Proposed Action Title: Aquanis, Inc. -- Active Aerodynamic Load Control for Wind Turbines

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): East Greenwich, RI; Warren, RI; Lubbock, TX; Richardson, TX

## **Proposed Action Description:**

Funding will support the project team's small-scale research and development activities to develop an advanced plasma actuator and demonstrate its efficacy as a key component of an active load control system for wind turbines. Specifically, the project team will (1) develop and test an advanced plasma actuator to increase the induced velocity of wind turbines above the current industry best; (2) complete baseline wind turbine designs for the purpose of developing simulation models; and (3) design, fabricate, install, and ground test a prototype active load control system capable of reducing unsteady aerodynamic forces on turbines associated with changes in the wind. If successful, the proposed active load control system could reduce the Levelized Cost of Energy (LCOE) for 4.7 and 20 MW offshore turbines by 13% and 34%, respectively, compared to state-of-the-art turbine technology.

Project activities will be conducted at existing facilities at Aquanis, Inc. (East Greenwich, RI), University of Texas at Dallas (Richardson, TX), TPI Composites, Inc. (Warren, RI), and Sandia's National Laboratory (Lubbock, TX) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work. Prime Recipient, Aquanis, Inc., under the terms of its ARPA-E Cooperative Agreement, is prohibited from commencing applicable project work before (1) obtaining the necessary permits and approvals and (2) providing written assurances to ARPA-E of the same

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
