Proposed Action Title: Carnegie Mellon University - Additive Manufacturing of Spacer Grids for Nuclear Reactors

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Pittsburgh, PA; Cranberry Township, PA

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to use additive manufacturing techniques to fabricate nuclear reactor spacer grids. Specifically, the project team will (1) fabricate and test baseline spacer grid subcomponents, (2) execute subcomponent builds that employ quality and performance enhancing parameters, and (3) build prototype spacer grids with optimized parameters. If successful, this project could lead to additive manufacturing for nuclear reactor component fabrication, enabling enhanced designs and lower costs.

Project activities will be conducted at existing facilities at Carnegie Mellon University (Pittsburgh, PA) and Westinghouse (Cranberry Township, PA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
