Proposed Action Title: University of Oklahoma -- An Innovative Zero-Liquid Discharge Intermediate-Cold-Liquid Eutectic-Freeze Desalination System

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Norman, Oklahoma

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a novel zero-liquid discharge (ZLD) method for purification of water produced from various industrial processes, including oil and gas extraction. Specifically, the project team will (1) develop computational models that can be used to predict the heat transfer in the system accurately and optimize the system design; (2) build a prototype desalination system using the results of the computational model; and (3) document the characteristics of the purified water and perform an economic analysis to compare with other desalination systems currently in the market. If successful, the purification system will be suitable for highly concentrated/contaminated water, with no need for energy-intensive evaporation processes, and capable of operating under atmospheric pressure, using low-cost construction material.

Project activities will be conducted at an existing facility at University of Oklahoma (Norman, OK) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.


To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
