Proposed Action Title: Vanderbilt University -- BIPOLAR MEMBRANES WITH AN ELECTROSPUN 3D JUNCTION

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Nashville, TN; Chattanooga, TN

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop bipolar membranes with an extended 3D water splitting or water formation junction region. Specifically, the project team will (1) fabricate a new and uniquely designed bipolar membrane (BPM); (2) optimize, characterize, and test membrane performance in two different applications; and (3) demonstrate that BPMs can be fabricated on commercial electrospinning equipment with the same performance as membranes made in the lab. If successful, the project will make it possible to operate a 3D junction BPM at current densities more than one order of magnitude greater than those achievable with the best commercially available film. Commercially, the BPMs could (1) reduce the size and capital cost of electro dialysis stacks; (2) allow for high power output from a self-hydrating fuel cell that operates at low relative humidity; and (3) open up new applications for BPMs.

Project activities will be conducted at existing facilities at Vanderbilt University (Nashville, TN) and eSpin Technologies, Inc. (Chattanooga, TN) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
