Proposed Action Title: Palo Alto Research Center, Inc. - Electrochemical Ammonia Synthesis with a Nitride Ion Conducting Electrolyte

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Palo Alto, CA; Bridgewater, NJ

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop an electrochemical solid-state ammonia generator that converts nitrogen and hydrogen gases to ammonia in a single step at moderate temperature. Specifically, the project team will (1) fabricate and optimize a scalable electrolyte membrane, (2) identify the highest performing electrocatalysts and optimize the electrode microstructure, and (3) fabricate component devices and demonstrate performance, durability, and scalability. If successful, this project could yield an ammonia production rate two orders of magnitude better than state-of-the-art electrochemical ammonia technologies.

Project activities will be conducted at existing facilities at Palo Alto Research Center (Palo Alto, CA), Social Capital (Palo Alto, CA), and Linde (Bridgewater, NJ) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
