Proposed Action Title: Donald Danforth Plant Science Center -- Augmented Reality GUI for Bioenergy Crop Phenotyping and Digital Agriculture

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to organize and store high complexity digital agriculture data in situ, by creating place-based, geolocated models of field sites at plot-, plant-, or leaf-level and then layering data for visualization and intuitive interaction via virtual reality (VR) and augmented reality (AR). Specifically, the project team will (1) conduct field experiments, planning, planting and operations with more than one crop type; (2) curate a catalog of sensor based datasets from TERRA-REF ("Transportation Energy Resources from Renewable Agriculture Phenotyping Reference Platform"); (3) train Classifier on TERRA data for genetic markers linked to visually distinct traits using 3D-scanner data from TERRA; and (4) develop algorithms for data driven trait signatures and structural correspondence. If successful, the project team's approach will allow users to examine and mine complex data in the context of the plant itself, expanding the impact of phenotyping and digital agriculture toward the development of new bioenergy feedstocks.

Project activities will be conducted at existing facilities at Donald Danforth Plant Science Center (Saint Louis, MO); University of Arizona (Maricopa & Tucson, AZ); George Washington University (Washington, DC); and Saint Louis University (Saint Louis, MO) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.


To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.
