<u>Proposed Action Title</u>: John Hopkins University - Carbon Dioxide-Free Hydrogen and Solid Carbon from Natural Gas via Metal Salt Intermediates

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Birmingham, AL; Baltimore, MD; Chevy Chase, MD; Billerica, MA

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a prototype system that implements the ETCH Process (a thermochemical cycle that decomposes natural gas to hydrogen and solid carbon) at a pilot scale and a model for scaling up the ETCH Process to industrially relevant scales. Specifically, the project team will (1) develop a process flow model capable of validation, including commercially available equipment and thermal management design; (2) conduct corrosion testing of candidate reactor construction materials; and (3) demonstrate a batch reactor for hydrogen production. If successful, upon commercial deployment, the ETCH Process would utilize natural gas with improved efficiency and reduced carbon dioxide emissions in multiple energy-intensive markets, particularly hydrogen and solid carbon production.

Project activities will be conducted at existing facilities at Johns Hopkins University (Baltimore, MD); ETCH, Inc. (Chevy Chase, MD); Southern Co. (Birmingham, AL); and Cabot Corporation (Billerica, MA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.
