Proposed Action Title: Geegah - Integrated Gigahertz Ultrasonic Imager for Soil: Towards Targeted Water and Pesticide Delivery for Biomass Production

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Ithaca, NY; Geneva, NY

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop an inexpensive multisensory wireless sensor-node that can image water content, chemical properties of soil, root growth, and nematode pests in soil at the sensor surface. Specifically, the project team will (1) design and fabricate sensor components, (2) build an experimental setup and develop analysis tools, (3) conduct field testing at an agricultural site, and 4) refine and improve technology based on testing results. If successful, this sensor package could replace expensive and laborious procedures with a low cost and widely deployable solution to increase biomass production capability.

Project activities will be conducted at existing facilities at Geegah LLC (Geneva, NY and Ithaca, NY) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work. Geegah, under the terms of its ARPA-E Cooperative Agreement, is prohibited from commencing applicable project work related to pesticides or field work before (1) obtaining the necessary permits and approvals and (2) providing written assurances to ARPA-E of the same.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
