Proposed Action Title: Massachusetts Institute of Technology -- CarbonHouse: A Scalable All-Carbon Building Logic

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop design and fabrication principles for using forms of carbon that can be derived from hydrogen-depleted feedstocks. Specifically, the project team will (1) establish design, material, manufacturing principles, and preliminary design of CarbonHouse; (2) measure the environmental, functional, and potential cost benefits of incorporating carbon materials for virtually all building elements; and (3) fabricate an off-grid pilot CarbonHouse. If successful, the team will demonstrate a new, essentially organic base-building logic, capable of displacing virtually all minerals and metals (possibly 80% of total building mass), significantly reducing the environmental footprint.

Project activities will be conducted at existing facilities at Massachusetts Institute of Technology (Cambridge, MA); Dexmat (Houston, TX); Janicki Industries (Sedro-Woolley, WA); d2 Solar (San Jose, CA); NanoComp (Merrimack, NH); TransSolar (New York, NY); Stanford University (Palo Alto, CA); Touchstone (Triadelphia, WV); and SoundDown (Salem, MA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
