Proposed Action Title: Neuvokas - Energy Efficient, Incrementally Scalable, Continuous Basalt Fiber Manufacturing Process

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Ahmeek, MI; Calumet, MI; Rancocas, NJ; Houghton MI

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to characterize and quantify an industrial-scale manufacturing process for continuous basalt fiber (CBF) to reinforce concrete. Specifically, the project team will (1) measure, quantify, and catalog potential materials to use in the process, (2) design and test production equipment, and (3) identify the best materials, designs, and methods to produce CBF. If successful, this project will be a step toward using CBF to replace steel in this application, leading to reduced energy use, emissions, and maintenance requirements.

Project activities will be conducted at existing facilities at Neuvokas Corporation (Ahmeek, MI), REL Inc. (Calumet, MI), Inductotherm Corp (Rancocas, NJ), and Michigan Tech University (Houghton, MI), designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. Minor modifications will be made to existing facilities to accommodate the proposed work, including installation of electrical systems. Neuvokas, under the terms of its ARPA-E Cooperative Agreement, is prohibited from commencing applicable project work involving facility modifications before (1) obtaining the necessary permits and approvals and (2) providing written assurances to ARPA-E of the same.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
