Proposed Action Title: Colorado School of Mines -- High-Throughput Discovery of Thermoelectric Materials

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Golden, CO; Minneapolis, MN

Proposed Action Description:

Funding will support the project team's small-scale research and development to develop a new methodology for discovering thermoelectric materials. Specifically, the team will (1) develop high throughput approaches critical to lowering the cost per sample and (2) enable thermoelectric material discovery in an extremely high dimensional structural and compositional space. If successful, this new methodology could create a significant force multiplier enabling thermoelectric materials discovery with high thermal-to-electric power conversion efficiency.

Project activities will be conducted at existing facilities at Colorado School of Mines (Golden, CO) and University of Minnesota (Minneapolis, MN) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.

Proposed Action Title: Colorado School of Mines - High-Throughput Discovery of Thermoelectric Materials

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop a new class of high performance thermoelectric materials with high solid state thermal-to-electric conversion efficiency. Specifically, the project team will: (1) demonstrate the application of high throughput 'dry' aerosol spray deposition to thermoelectric materials discovery; (2) prepare and characterize bulk materials; and (3) validate promising compositions against traditional measurements. If successful, these efforts will create new markets not addressable by traditional mechanical heat recovery systems.

Project tasks will be conducted on a small-scale basis in dedicated laboratory, testing, and fabrication facilities at Colorado School of Mines (Golden, CO) and University of Minnesota (Minneapolis, MN). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.
