Proposed Action Title: Cornell University -- Advancing a Low Carbon Built Environment With Inherent Utilization of Waste Concrete and CO₂ via Integrated Electrochemical, Chemical and Biological Routes (ADVENT)

Proposed Action Description:

Funding will support the project team's small-scale research and development of an integrated technology to produce calcium (Ca)-silicates needed for Ordinary Portland Cement by harnessing low-cost renewable electricity to produce cementitious materials with the co-utilization of construction and demolition (C&D) materials and carbon dioxide (CO₂) emissions. Specifically, the project team will (1) electromicrobially synthesize elements to produce Ca-silicates and (2) generate hydrogen and carbon materials from organic components of C&D materials to produce sustainable construction materials. If successful, this project will result in technology that replaces thermally intensive processes for producing construction materials with integrated electrochemical and chemical approaches, enabling distributed, on-demand synthesis of sustainable construction materials, while reducing greenhouse gas emissions.

Project activities will be conducted at existing facilities at Cornell University (Ithaca, NY), Carnegie Mellon University (Pittsburgh, PA), Columbia University (New York, NY), and Reaction Engineering International (Salt Lake City, UT) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.
