Proposed Action Title: IBM Research -- Systems Two-Phase Cooling

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Poughkeepsie, NY; Yorktown Heights, NY

Proposed Action Description:

Funding will support the project team's research and development activities to develop an energy efficient two-phase cooling system for data centers to reduce cooling energy consumption and eliminate water usage compared to traditional air-cooled systems. Specifically, the project team will (1) develop a preliminary system model to define component specifications; (2) test complete system model on thermal test vehicle; (3) characterize condenser and fabricate cold plate designed to meet requirements for a high-end server; and (4) validate three-drawer system at benchmark workload consistent with commercial application. If successful, the project team's two-phase cooling system will eliminate the need for energy intensive compressor-based cooling used in typical air-cooled data centers, which utilizes 25-35% of total data center energy usage and deploy evaporative cooling towers that consume water. Two-phase cooling technology can potentially save US data centers 19 Billion kWh of electricity usage and 160 billion gallons of water consumption per year.

Project activities will be conducted at an existing facility at IBM (Poughkeepsie, NY & Yorktown Heights, NY) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
