Proposed Action Title: Massachusetts Institute of Technology -- Liquid Immersion Blanket: Robust Accountancy

Program or Field Office: Advanced Research Projects Agency - Energy

<u>Location(s) (City/County/State)</u>: Idaho Falls, ID; Cambridge, MA

Proposed Action Description:

Funding will support the project team's research and development activities to design, develop, and test a critical path tritium (T) breeding experiment for Liquid Immersion Blanket technology. Specifically, the project team will investigate the validity of a radically simple molten-FLiBE-salt approach to T breeding for fusion power plants using experimental investigations and T management and modeling. The project team will also fabricate a representative scale T breeding test stand that is compact, provides containment and continuous T extraction capability. If successful, the project team's Liquid Immersion Blanket: Robust Accountancy (LIBRA) experiment will enable T Breeding Ratios required for rapid fusion expansion at 70% lower cost than state-of-the-art breeding blankets.

Project activities will be conducted at existing facilities at Massachusetts Institute of Technology (Cambridge, MA) and Idaho National Laboratory (Idaho Falls, ID) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
