<u>Proposed Action Title</u>: The Ohio State University -- Vehicle Traction Electric Machines Enabled by Novel Composite Magnetic Powder Material and Electrophoretic Deposition Insulation Material

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Columbus, OH; Niskayuna, NY; Dearborn, MI

Proposed Action Description:

Funding will support the project team's small-scale research and development of innovative magnetic and insulation materials to build electric machine cores and machine cooling structures, which will be used in electrified vehicles. Complex machine cooling structures using ceramic electrophoretic deposition (EPD) insulation will be developed and tested, then added to the electric machine core. If successful, a 100-kW, 15,000-rpm prototype vehicle traction machine will be designed and built using the proposed CMP and EPD materials. Developing new materials and new manufacturing methods are estimated to improve torque density by 40% to 70%, and would reduce the manufacturing costs of electric machines for vehicle traction applications.

Project activities will be conducted at existing facilities at The Ohio State University (Columbus, OH), GE Global Research Center (Niskayuna, NY), and Ford Motor Company (Dearborn, MI), designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
