Proposed Action Title: Precision Combustion - Additively-Manufactured Electrochemical-Chip Based Scalable Solid Oxide Fuel Cells

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a scalable electrochemical chip for energy production. Specifically, the project team will demonstrate a multi-functional solid oxide fuel cell (SOFC) architecture that permits a power dense, lightweight design for transportation applications and is combined with an ultra-compact reforming technology. If successful, a path to achieving low cost, net-zero carbon footprint, use of sustainable fuels, and high fuel to electric efficiency will be achieved through fabrication of an electrochemical chip.

Project activities will be conducted at existing facilities at Precision Combustion, Inc, (North Haven, CT), CT Center for Advanced Technology, (East Hartford, CT), Colorado School of Mines, (Golden, CO), Kent State University, (Kent, OH), and Electrochemical Energy Consultants, LLC (Storrs, CT) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
