Proposed Action Title: Sandia National Laboratories - Hybrid Switched Capacitor Circuit Development for Use of GaN Diodes in High Gain Step-Up Converters (Hy-GaN)

Program or Field Office: Advanced Research Projects Agency - Energy (ARPA-E)

Location(s) (City/County/State): Albuquerque, New Mexico

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to develop a breakthrough, modular, mass-producible, textbook-size converter capable of 10 kW or greater that can fit onto a single circuit board. Specifically, the project team will (1) conduct a converter simulation study; (2) design, build and test an initial prototype using commercial off-the-shelf devices; (3) design and build a final prototype and incorporate custom features; and (4) demonstrate both prototypes with a real photovoltaic source. If successful, the smaller converter will yield cost savings from construction, shipping, installation, and energy conversion of industrial-scale and utility-scale photovoltaic generation systems.

Project activities will be conducted at an existing facility, Sandia National Laboratories (Albuquerque, New Mexico), designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facility to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
