Proposed Action Title: University of California, Los Angeles - Self-Aqueous-Based High-Performance Electrochemical Energy Storage

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Los Angeles, CA; Manhattan Beach, CA

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop high-power superbatteries, which will be integrated with high-energy-density batteries to construct robust affordable energy storage systems for electric vehicles. Specifically, the project team will: (1) develop cathode additives; (2) develop anode additives; (3) assemble fuel cells using doped cathodes and doped or tungsten oxide anodes; and (4) develop working fuel cell. If successful, the superbatteries will provide better energy storage for a number of critical applications.

Project tasks will be conducted in dedicated laboratory and testing facilities at University of California, Los Angeles (Los Angeles, CA) and Volta Materials (Manhattan Beach, CA). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements.

Proposed Action Description:

The University of California proposes to conduct small-scale, laboratory based, research, development, and testing of a novel pseudocapacitive material, enabling the fabrication of aqueous supercapacitors and superbatteries. The proposed activities will focus on improving performance, including high power and long cycling life. The proposed activities aim to promote the development of superbatteries to construct robust, affordable energy storage systems for electric vehicle applications.
