Proposed Action Title: Northrop Grumman Aerospace Systems - Full Spectrum Power for Optical/Thermal Exergy (FSPOT-X)

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Redondo Beach, CA; Pasadena, CA; Tempe, AZ

Proposed Action Description:

Northrop Grumman Aerospace Systems, in conjunction with Jet Propulsion Laboratory, Southwest Solar Technologies LLC (Southwest Solar), Spectrolab, Emcore, and Sharp, proposes to conduct laboratory-based, small-scale research and development activities to develop an integrated hybrid power generation device that produces electricity from sunlight.

No modifications will be made to existing facilities to accommodate the proposed work. Southwest Solar will conduct outdoor testing in an existing facility in Tempe, AZ. This outdoor testing will comply with applicable land-use and zoning requirements and will incorporate appropriate control technologies and best management practices. The remaining project work of other team members will take place in controlled indoor laboratory facilities in Redondo Beach, CA and Pasadena, CA.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
