Proposed Action Title: Yale University (Yale) - Dual-Junction Solar Cells for High Efficiency at Elevated Temperature

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): New Haven, CT; Golden, CO; Albuquerque, NM

Proposed Action Description:

Yale, in conjunction with the National Renewable Energy Laboratory (NREL) and Emcore Corporation, proposes to conduct small-scale research and development activities to develop a high-temperature, extended-life, dual-junction solar cell that uses a wide solar spectrum to convert light wavelengths into electricity and dispatchable heat. All project activities will take place in Yale's laboratory in New Haven, CT; NREL's laboratory facilities in Golden, CO; and Emcore's laboratory in Albuquerque, NM.

Additional work locations may be added to this project in the future to accommodate outdoor testing of a prototype cell. Upon selection of an additional work location, ARPA-E will perform a review of all activities to be carried out by the proposed site and issue a categorical exclusion, if appropriate. No work may begin at any location other than the above-mentioned laboratory facilities without prior written authorization from the ARPA-E NEPA Compliance Officer.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
