Proposed Action Title: SRI International (SRI) - Wearable Active Textile for Physiology-Based Thermal Management

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Menlo Park, CA; Stanford, CA; and Los Angeles, CA

Proposed Action Description:

Funding will support the development of a thermoregulatory textile that utilizes low-cost polymer materials and unique structures to efficiently manage heat transfer. If successful, thermally adaptive materials could be incorporated into low-cost garments and accessories to provide office workers comfort in a broader range of temperatures and reduce the overall energy costs of heating and cooling buildings by broadening the setpoints of building HVAC systems.

Project tasks will be conducted at SRI's laboratory facility in Menlo Park, CA; the University of California, Los Angeles' laboratory facility in Los Angeles, CA; and Stanford University's laboratory facility in Stanford, CA in accordance with applicable Federal, State, and local safety and environmental requirements. Research performed by Stanford University will include collection of physiological data in a thermally controlled laboratory setting similar to a typical office environment that is subject to, and will comply with the requirements of: (1) DOE Order No. 443.1B (Protection of Human Research Subjects); (2) 10 C.F.R. Part 745; and (3) 45 C.F.R. Part 46.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
