Proposed Action Title: University of California, San Diego (UCSD) - Adaptive Textiles Technology with Active Cooling & Heating

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): San Diego, CA

Proposed Action Description:

Funding will support research and development of a thermally-adaptive textile that utilizes a unique structure and thermoelectric components to adjust the material's thermoregulative properties based on shifts in ambient temperature and humidity. If successful, thermally adaptive clothing could enable wearer comfort in a broader range of temperatures and reduce the overall energy costs of heating and cooling buildings by broadening the setpoints of such systems.

Analytical modeling and commercialization activities will be performed by Electrozyme in its office facility in San Diego, CA. All remaining project work will take place at UCSD's laboratory facility in San Diego, CA. All work will be conducted in accordance with applicable federal, state, and local requirements.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
