Proposed Action Title: Georgia Tech Research Corporation -- A Novel ITFC Tailored for Efficient Utilization of Methane

Program or Field Office: Advanced Research Projects Agency-Energy

Proposed Action Description:

Georgia Tech Research Corporation, in conjunction with University of Kansas, proposes to conduct small-scale, laboratory-based research to develop a commercially viable intermediate temperature fuel cell (ITFC) system which can efficiently convert hydrocarbon fuels (e.g. methane or natural gas) directly to electricity at 200-500°C. Specifically, the project team will: (1) fabricate and characterize multi-layered anode support substrates; (2) fabricate and characterize mixed proton/oxygen anion electrolyte membranes; (3) modify anode substrates with catalysts to achieve multi-functionality; (4) fabricate and characterize high-performance cathodes; (5) fabricate and test large area cells; and (6) demonstrate a 7-cell stack.

All project tasks will be performed in dedicated industrial and university laboratory facilities at Georgia Tech Research Corporation (Atlanta, GA) and University of Kansas (Lawrence, KS).

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
