Proposed Action Title: Brayton Energy, LLC (Brayton) - 1kWe Recuperated Brayton Cycle Engine Using a Screw Compressor and Expander

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Hampton, NH

Proposed Action Description:

Funding will support research and development activities to develop a small-scale, high efficiency, recuperated Brayton-cycle engine for use as a residential Combined Heat and Power (CHP) system. The proposed engine will integrate a ceramic screw expander, intake recuperator, and ultra-low emissions combustor to increase generator efficiency and expand the temperature range at which the CHP system can operate. If successful, widespread deployment of highly efficient, compact, economical, and long-life residential CHP systems in the United States could lead to significant energy savings and a reduction in CO2 emissions associated with power plant electricity generation and household heating.

All research and development activities will be conducted in Brayton's laboratory facility located in Hampton, NH. All work will be performed in accordance with applicable Federal, State, and local safety and environmental requirements.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
