Proposed Action Title: Georgia Tech Research Corporation - Scalable and Robust Zeolitic Imidazolate Framework Membranes Supported on Hollow Fibers for Olefin Separations

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop pure metal-organic framework (MOF) membranes for propylene/propane separation. Specifically, the project team will: (1) develop hollow fibers to evaluate for membrane formation; (2) develop hollow fiber modules for propane/propylene separation, including development of membrane fabrication and testing apparatus; and (3) conduct techno-economic analysis to evaluate the economic potential of the membrane separation technology. If successful, the proposed membrane separation technology applied to propylene production could result in significant cost savings and reductions in CO2 emissions. Membrane fabrication and testing will be conducted in an existing laboratory at Georgia Institute of Technology.

Project tasks will be conducted on a small-scale basis in dedicated laboratory and testing facilities at Georgia Tech Research Corporation/Georgia Institute of Technology (Atlanta, GA); Missouri University of Science & Technology (Rolla, MO); Phillips 66 Company (Bartsville, OK). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
