Proposed Action Title: Hi Fidelity Genetics LLC - Non-Invasive Field Phenotyping Device for Plant Roots

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Durham, NC; Atlanta, GA; Santa Rosa, TX; Texline, TX; Wharton, TX

Proposed Action Description:

Funding will support research and development activities to develop the RootTracker, a device that measures plant root traits, including root angles and root growth, across environments that vary by soil type and moisture level. If successful, the RootTracker will improve root architecture optimization and energy efficiency through more efficient use of sunlight, reduced use of fossil fuels, and lower greenhouse gas concentrations. Specifically, the project team will: (1) design and fabricate the prototype cage; (2) conduct indoor testing of the prototype cage by growing plants in the laboratory to determine root detection conditions; and (3) conducting field testing using conventional corn to determine the durability of the RootTracker. Field testing will be conducted at three locations in Texas on land rented by GroAlliance; the site will be prepared as would for normal corn yield trial. No permits or other authorizations are required for the field testing.

Project tasks will be conducted on a small-scale basis in dedicated laboratory, testing, and fabrication facilities at Hi Fidelity Genetics LLC (Durham, NC); Georgia Institute of Technology (Atlanta, GA); and GroAlliance (Santa Rosa, TX; Texline, TX; and Wharton, TX). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.


To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
