Proposed Action Title: University of Maryland, College Park - Highly Conductive, Robust, Corrosion-Resistant Nanocarbon Current Collectors for Aqueous Batteries

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop flexible, robust and corrosion-resistant few-walled carbon nanotube (FWNT)-polymer film as current collectors for aqueous battery applications. Specifically, the project team will: (1) design the films per required properties for optimized current collectors; (2) fabricate and characterize FWNT-polymer film; (3) design electrochemical methods to evaluate the corrosion behavior of the FWNT-polymer film; (4) develop current collectors suitable for use in lead acid and nickel-metal hydride batteries; and (5) identify and analyze preferred version of FWNT-polymer film for materials and fabrication cost. If successful, the FWNTs will enable both high direct current conductivity and excellent mechanical strength that can be applied to a range of aqueous batteries and other battery chemistries.

Project tasks will be conducted on a small-scale basis in dedicated laboratory, testing, and fabrication facilities at University of Maryland, College Park (College Park, MD). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.


To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
