Proposed Action Title: University of Tennessee, Knoxville - Advanced Reversible Aqueous Air Electrode

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Knoxville, TN; Rochester, NY; Atlanta, GA

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop an advanced aqueous reversible air electrode that can greatly increase the efficiency of rechargeable air batteries and that can be deployed in an electrochemical peroxide generation system. Specifically, the project team will: (1) test reversible air cathode performance; (2) develop and control membrane and membrane-electrode assembly structures; (3) design and build different two phase flow field for peroxide production; and (4) design and build cells and systems for peroxide generation and metal anodes. If successful, the electrode will have high operation efficiency at reduced hydrogen peroxide production cost, making air battery technology much more competitive with other energy storage systems.

Project tasks will be conducted on a small-scale basis in dedicated laboratory, testing, and fabrication facilities at University of Tennessee, Knoxville (Knoxville, TN); Peroxygen Systems, Inc. (Rochester, NY); and Institute of Paper Science and Technology (Atlanta, GA). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
