Proposed Action Title: Donald Danforth Plant Science Center (Danforth) - Center for Enhanced Camelina Oil

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Lincoln, NE and Bozeman, MT

Proposed Action Description:

During February 2014, laboratory and greenhouse-based tasks for Danforth's effort to develop transgenic Camelina sativa that can be readily converted into a biofuel were determined to be categorically excluded from further NEPA review under Categorical Exclusion B3.6 by the ARPA-E NEPA Compliance Officer. This determination covers outdoor field trials that were not previously addressed.

Transgenic camelina plants will be moved between the University of Nebraska's (Nebraska) greenhouse facilities in Lincoln, NE, to a dedicated, fenced-off agricultural field research site located 1 mile from the greenhouse facility which is owned and operated by Nebraska. Nebraska will plant transgenic camelina in a field trial plot that will have a minimum isolation perimeter of 200 meters from any sexually compatible relatives (with a perimeter fallow area of 10 feet). Field trials will continue from April 2015 to March 2016. In addition, transgenic camelina plants will be moved between Montana State University's (Montana) greenhouse facilities in Bozeman, MT, to a dedicated, fenced-off experimental farm located 1 mile from the greenhouse facility which is owned and operated by Montana. Montana will plant the transgenic camelina in a field trial plot that will have a minimum isolation perimeter of 1 mile from commercial plantings of camelina (with a perimeter fallow area of 200 meters). Field trials will continue from April 2015 to April 2016.

Outdoor field trials will be conducted in accordance with the protective measures described in standard release permits issued by U.S. Department of Agriculture's Biotechnology Regulatory Services to Nebraska and Montana to ensure that transgenic plant materials are not released in an unauthorized manner into the environment.

Proposed Action Title: (0470-1517) Donald Danforth Plant Science Center - Center for Enhanced Camelina Oil

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Michigan, Missouri, Montana, Nebraska, New Mexico

Proposed Action Description:

Funding will support development of genetically modified (GM) camelina that grows at an increased yield and produces more seed oil than wild-type camelina for use as a biofuel feedstock.

Proposed work will consist of (1) genetically modifying camelina to improve carbon capture/ assimilation and light utilization, and to redirect carbon flux towards seed oil synthesis, including synthesis of oleic acid; (2) fabricating and testing phenomics chambers used to analyze plant metabolism under varying conditions (e.g. humidity, temperature); (3) growing selected lines of non-GM, wild-type camelina in contained agricultural research fields for baseline analysis; (4) analyzing the GM camelina plants produced using the phenomics chambers to determine if the genetic modifications were successful; and (5) analyzing GM camelina plants produced using standard laboratory techniques to determine if they meet target milestones for biomass accumulation and seed oil content. This project will not involve field testing with GM plants.

Proposed work involving GM camelina will take place at dedicated indoor laboratory and greenhouse facilities at Donald Danforth Plant Science Center (St. Louis, MO), the U.S. Department of Agriculture's Agricultural Research Service (St. Louis, MO), University of Nebraska - Lincoln (Lincoln, NE), Michigan State University (East Lansing, MI), New Mexico Consortium (Los Alamos, NM), and Montana State University (Bozeman, MT). Confined field testing of non-GM, wild-type camelina will occur at Montana State University (Bozeman, MT). All organizations handling recombinant DNA will receive approval from their Institutional Biosafety Committees prior to beginning work with recombinant DNA molecules.
