<u>Proposed Action Title</u>: Verne, Inc. -- Decoupling High-Density Hydrogen from the Liquid Hydrogen Infrastructure: Catalyst-Filled Heat Exchangers for Modular Cryo-Compressors

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): San Francisco, California; Livermore, California

Proposed Action Description:

Funding will support the project team's small-scale research and development of a cryo-compressor technology platform that will convert gaseous hydrogen (GH2) at low pressures (e.g., 20 bar) and ambient temperature (e.g., 300 Kelvin[K]) to cryo-compressed hydrogen (CcH2) at 60–80K and 300–500 bar. Specifically, the project team will (1) conduct iterative process modeling and system design, (2) develop and test preliminary prototypes, and (3) construct and test full-scale cryo-compressor system. If successful, this project will result in high-density, low-cost hydrogen storage as part of achieving an economical hydrogen infrastructure by validating cryo-compressors as a way to decentralize high-density hydrogen and accelerate deployment and utilization of electrolysis and the broader hydrogen infrastructure of the U.S.

Project activities will be conducted at existing facilities at Verne, Inc. (San Francisco, CA) and Lawrence Livermore National Laboratory (Livermore, CA) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
