Proposed Action Title: National Renewable Energy Laboratory - Real-time Optimization and Control of Next-Generation Distribution Infrastructure

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale, research and development activities to develop a comprehensive distribution network management framework that unifies real-time distributed energy resources (DER) control with network-wide energy management under an integrated framework. Specifically, the project team will: (1) develop controllers; (2) develop dynamic optimization algorithms for software; (3) define platforms and test cases to be utilized for software simulation; and (4) conduct power hardware-in-the-loop (HIL) testing, controller HIL testing, and software simulation. If successful, the framework would facilitate greater grid resiliency, security, and flexibility, while having minimal impact on customer quality of service.

Project tasks will be conducted in dedicated laboratory, testing, and fabrication facilities at National Renewable Energy Laboratory (Golden, CO), California Institute of Technology (Pasadena, CA), University of Minnesota (Minneapolis, MN), Harvard University (Cambridge, MA), and Southern California Edison (Westminster, CA). Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
